Public Credit Registry

• RBI has constituted a High Level Task Force on Public Credit Registry (PCR) that can provide a roadmap for developing a powerful credit information system.

\n

• PCR is an extensive central database of bank loans (credit information) that is accessible to all stakeholders.

\n

• It captures credit data on all kinds of loans which will be helpful in improving assessment of credit risk by the banks, early detection of non-performing assets (NPAs), and to improve recovery of loans.

\n

- It certifies the details of collaterals, can enable the writing of contracts that prevent over-pledging of collateral by a borrower.
- \bullet It will also help to prevent multiple financing against the same property. $\mbox{\ensuremath{\backslash}} n$
- Initially, PCR will cover banks' customers which can then be expanded to cover other financial institutions (NBFCs).
- It will be managed by a public authority like the central bank.
- It would help in enhancing efficiency of the credit market, increase financial inclusion, and improve ease of doing business and help control delinquencies.

• The IBSA Dialogue Forum is an international tripartite grouping for promoting international cooperation among India, Brazil, and South Africa.

• It was formalized through the adoption of the "**Brasilia Declaration**" in 2003.

 It promotes the international poverty alleviation and social development with main focus being on equitable development.

• The countries have recently signed the **IBSA Trust Fund Agreement** that seeks to fight poverty in developing countries.

 \bullet Each country contributes USD 1 million annually to this fund which is managed by the UN Development Programme (UNDP). $\$

• The United Nations is an international organization founded in 1945 after the World War II.

- Its charter was signed in San Francisco on June 26, 1945 and came into existence on October 24, 1945 after 51 countries have signed the charter.
- With the ratification of the founding document by the majority of its signatories, including the five permanent members of the Security Council, the United Nations officially came into being.

• UN Day marks the anniversary of the entry into force in 1945 of the UN Charter.

- Since 1948, 24th October has been celebrated as United Nations Day.
- It is headquartered in New York.

• It has 193 members and latest member joined was South Sudan.

• The Official Languages are Arabic, English, French, Chinese, Spanish, and Russian.

• The organs of UN are General Assembly, Security Council, Economic and Social Council, International court of Justice and Secretariat.

• India's first Pradhan Mantri Kaushal Kendra (PMKK) for Skilling in Smart Cities was recently launched.

- It was established by National Skill Development Corporation (NSDC), in collaboration with New Delhi Municipal Council (NDMC).
- It aims to provide skill training for unemployed youth through its short-term training (STT) module and contribute to the capacity building of municipal employees through Recognition of Prior Learning (RPL) program. \n
- It signifies integration and convergence approach towards the Skill India Mission and the Smart City Mission.

- It is an outcome based skill certification scheme implemented by National Skill Development Corporation (NSDC), an executive arm of Ministry of Skill Development and Entrepreneurship.
- The objective is to enable a large number of Indian youth to take up industry-relevant skill training that will help them in securing a better livelihood.
- Individuals with prior learning experience or skills will also be assessed and certified under Recognition of Prior Learning (RPL).
- \bullet Training and Assessment fees are completely paid by the Government. $\mbox{\ensuremath{\backslash}} n$
- The Various components are short term training, recognition of prior learning, special projects, kaushal and rozgarmela, placement guidelines and monitoring guidelines.

Comet Rings

• NASA Scientists have spotted narrow dense rings of comets coming together to form massive planets.

• It is found on the outskirts of at least 3 distant solar systems with at least the size of a few Earths.

- \bullet Its mass is estimated based on the amount of light they reflect. $\ensuremath{^{\backslash n}}$
- The bright outer rings composed of comet like bodies at 75 to 200 astronomical units from their parent stars which is about 2 to 7 times the distance of Pluto from our own Sun.

• The composition of the material in these rings varies from ice - rich to icedepleted but carbon rich.

\n

 The scientists are especially intrigued by the red dust ring surrounding the planet "HR 4796A", which shows unusually tight form for an infant solar system.
