Outcome Budgeting



Recently the Assam government launched its budget for the financial year 2024-25 which is the front-runner in adopting SDGs and preparing SDG-linked outcome budgets at the subnational level in the country.

- Outcome budgeting is a budget process that connects *resources with results*.
- The concept of outcome budgeting was introduced in India in 2005.
- It mandates that the ministries and departments at all levels should be involved in a meaningful way in the implementation processes of the developmental schemes across the country.
- The *main objective* of the Outcome Budget is to create a direct connection between the financial investments made by the government in various programs and schemes, and the results expected from those expenditures.
- Key aspects of Outcome Budget in India:
 - $\circ~$ **Performance Evaluation** Each ministry and department is required to provide detailed information about the performance indicators and targets for each program and scheme.
 - **Enhanced Accountability** By focusing on outcomes rather than just financial outlays, the Outcome Budget holds government entities more accountable for delivering results.
 - $\circ~$ Transparency The Outcome Budget is a tool for promoting transparency in governance.
 - **Regular Reporting and Assessment** Ministries and departments are required to regularly report on their progress towards achieving the stated outcomes.
 - **Policy Decision-Making** To provide a clear picture of the effectiveness of various programs and schemes.
- **Outcome budget statements (OBS)** It is a budgetary instrument that links expenditure to specific targets by indicating the output / outcome to be achieved by making that expenditure.

- It helps align government policies, strategies and budgets towards achieving UN-mandated Sustainable Development Goals (SDG).
- States Outcome budgeting is not followed in all states.
- Around 11 Indian states including Assam have started following the practice of formulating their OBSs in the past few years.
- **Outcome budgeting in Assam** Assam was the first Indian state to adopt the SDGs in 2016 and its budgeting focused on SDG outcomes as outlined in Assam Agenda 2030.
- Assam introduced the OBS alongside the state's annual budget in in 2018-19.

U-Report

In a recent survey conducted by UNICEF's public-private youth platform, U-Report, has revealed that that 55% of women prefer to work from home so that they can manage the house chores too.

- U-Report is a social messaging tool developed by **the United Nations Children's Fund (UNICEF)** to engage with communities and gather real-time data on various issues.
- U-Report uses SMS and social media to conduct polls and surveys, allowing individuals to share their opinions on different topics, including education, health, and social issues.
- Key findings of the report 55% of women prefer to work from home so that they can manage the house chores too.
- 75% of young women and men believe that finding a job is the most important next step for the women post their studies.
- $\bullet\,$ Less than 1/5th believe that women should get married immediately after completing their academics.
- Almost 52% of the respondents believe that access to information and opportunities or support from families are key factors that influence young women's decision to develop job-ready skills and join the workforce.
- 56% of the respondents believed that parents/family or partners are important actors in choosing aspirations and career options.
- 42% male and 47% female respondents believe that parents and family members of young women make decisions with regard to their dreams and aspirations.
- 33% male and 37% female respondents believe that young women themselves make the decision for their dreams and aspirations.

Indian Kangaroo Lizard

A team of scientists from India has recently discovered a new species of Agasthyagama, commonly known as the Indian kangaroo lizard, in the Idukki district of Kerala.

- The Indian kangaroo lizard is a *small to medium-sized lizard*, typically growing up to 10 inches (25 cm) in length.
- It has a slender body, long legs, and a distinctive head with a pointed snout.
- It belongs to the genus *Agasthyagama* and has been named *Agasthyagama Edge*.
- It has been named Agasthyagama Edge, where the edge stands for Evolutionarily Distinct and Globally Endangered.
- It is endemic to the Western Ghats of India.
- It is characterised by a reduced fifth toe, these lizards are *inefficient climbers* and primarily inhabit terrestrial environments with dense leaf litter cover.
- The species is known for its bipedal movement and can run on its hind legs with its body held upright, *similar to a kangaroo*.
- This unusual gait is thought to help it escape predators and navigate through its rocky habitat.



Indira Gandhi National Centre for the Arts (IGNCA)

- The Indira Gandhi National Centre for the Arts (IGNCA) was launched on 19th November, 1985 by the late Prime Minister Shri *Rajiv Gandhi*.
- The IGNCA was established in 1987 as *an autonomous institution under the Ministry of Culture* as a centre for research, academic pursuit and dissemination in the field of the arts.
- It is a cultural repository and the custodian of ancient texts.
- It has a trust (*Board of Trustees*), which meets regularly to give general direction about the Centre's work.
- The *Executive Committee*, drawn from among the Trustees, functions under a Chairman.
- It acts as a link between the Trust and the IGNCA.
- The Member Secretary is the Executive head of both academic and administrative divisions.
- **Functional units** It has 6 functional units, that include:
 - 1. Kala Nidhi The multi-form library
 - 2. Kala Kosa Devoted mainly to the study and publication of fundamental texts in Indian languages
 - 3. Janapada Sampada Engaged in lifestyle studies
 - 4. **Kaladarsana** The executive unit which transforms researches and studies emanating from the IGNCA into visible forms through exhibitions
 - 5. **Cultural Informatics** Which applies technology tools for cultural preservation and propagation
 - 6. **Sutradhara** The administrative section that acts as a spine supporting and coordinating all the activities.





- Few initiatives of IGNCA include:
 - The Vedic Heritage Portal A "one-stop solution" for all things Vedas.
 - $\circ\,$ Digital courses on Vastu and Vedas
 - $\circ\,$ A website dedicated to Sengol, a symbol of the government's narrative in which a talisman represents the shedding of servility and newfound freedom.

GSLV-F14/INSAT-3DS Mission

Recently the GSLV-F14/INSAT-3DS mission was successfully launched by the ISRO.

- The GSLV is the launch vehicle of the mission that aims to deploy the INSAT-3DS meteorological satellite into the Geosynchronous Transfer Orbit (GTO).
- INSAT-3DS Satellite is a follow-on mission of Third Generation Meteorological Satellite from Geostationary Orbit.
- The mission is fully funded by the Ministry of Earth Sciences (MoES).
- The mission is designed to operate in space for ten years, is expected to boost environment monitoring, oceanic observations and weather forecasting and assist disaster relief operations.
- The satellite will augment the Meteorological services along with the presently operational INSAT-3D and INSAT-3DR satellites.
- Indian Industries have significantly contributed to the making of the Satellite.
