- **Treatment** - There is *currently no vaccine*, and antiviral treatment is not recommended.

Cold Wave Definition

- The United Nations Office for Disaster Risk Reduction defines cold wave as a phenomenon where surface temperatures in an area fall below a certain threshold for *at least 2 consecutive days. (Statement 1 is incorrect).*
- According to the IMD, a cold wave is declared when minimum temperatures are *10°C or lower in the plains, or 0°C or lower in the hills, sustained over 3 consecutive days. (Statement 2 is incorrect).*

| Malabar Raven Butterfly | <ul style="list-style-type: none"> • This butterfly is part of the Papilio genus, which includes the Helen and Mormon Swallowtails. |
| Malabar Tree Toad | <ul style="list-style-type: none"> • It is the <i>only arboreal species in India</i>, having the unique capability to climb trees. • It is found in forests along the Western Ghats of great Karnataka or Deccan. |
