- Scientific Name is “Milvus migrans”
- It typically lives in social groups and the ***major Threats include- Poisoning, Shooting, Electrocution by power lines, Pollution of water by pesticides and other chemicals.*** (Statement 3 is correct.)

- **Ropar Wetlands (2002)** is a freshwater riverine wetland on the banks of Sutlej River.
- **Nangal Wetlands (2019)** is a man-made reservoir from the Bhakra-Nangal Project which is located in the foothills of the Shiwalik range.
