# Acute Promyelocytic Leukemia (APL)

- APL is a rare but serious blood cancer characterized by the abnormal accumulation of immature *white blood cells called promyelocytes*, often leading to severe bleeding and clotting problems.
- Often treated with a combination of chemotherapy and non-chemotherapy drugs like all-trans-retinoic acid (ATRA) and arsenic trioxide (ATO).
