House Hold Debt in India

- Household debt in India refers to the total amount of debt owed by households to various financial institutions.
- It is measured as a percentage of GDP (Gross Domestic Product), representing the total borrowings of households relative to the size of the economy.
- Components of household debt
 - **Unsecured loans** Personal loans, credit cards, consumer durables
 - **Secured loans** Housing, Gold and vehicle loans
 - Retail credit from NBFCs (Non-Banking Finance Companies) and HFCs (Housing Finance Companies)
 - Loans from microfinance institutions
- Since household debt includes both the <u>unsecured loans and secured</u> <u>loans</u>, **statement 2 is incorrect.**
- Household debt in India It has experienced a dramatic surge in the post-pandemic period
 - ∘ 2021 36.6% of GDP
 - 2023 40.2% of GDP
 - 2024 42.9% of GDP
- Since Household debt in India is <u>increasing in the recent years</u>, statement 3 is incorrect.
